Authorization for CEO to Execute Shelter plus Care (S+C) 18 Unit Expansion

Amendment with Broward County

REQUESTED ACTION:

Motion to grant authorization to the Chief Executive Officer to execute an amendment to the S+C 18 Unit Expansion funding agreement between Broward County and BCHA for a Rental Assistance Program, Agreement #17-CP-HIP-8264-01 commencing October 1, 2018 and ending September 30, 2019.

WHY ACTION IS NECESSARY:

Board approval is required to execute this agreement.

WHAT ACTION ACCOMMPLISHES:

Amends the S+C 18 Unit Expansion project which will allow BCHA to provide rental assistance to an additional 34 homeless clients.

SUMMARY EXPLANATION/BACKGROUND:

The S+C 18 Unit Expansion project, Program 2, will provide rental assistance for permanent housing in scattered sites throughout Broward County and supportive services through collaboration with the Broward County Family Success Housing Options Support team including intensive case management and other services based on individual client needs, the target population is homeless individuals and families living in Broward County.

In addition, the administrative fee earned under Program 1, is increased from 7% to 10% of the grant amount.

EXHIBIT D-1 - SCOPE OF SERVICES

Provider: Broward County Housing Authority
Program: Shelter Plus Care 18 Unit Expansion B

Program #: 2

I. Scope of Services:

- A. Program description: Provider will provide monthly rental assistance to homeless individuals and families for permanent housing units throughout Broward County.
- B. Target population: Homeless individuals who are 18 years and older and/or families residing in Broward County ("Clients").
 - 1. Eligibility criteria:
 - a. Clients must be meet the definition of Homelessness under Categories 1 and 4 as referenced in the Provider Handbook.
 - b. Provider will receive Client referrals through the Continuum of Care's Coordinated Assessment System.
 - 2. Documentation of eligibility:
 - a. Certification of homelessness from Provider or another third party such as, an outreach provider, other emergency shelters, documented intake worker's observations, or certification from the person seeking assistance.
 - b. Provider will comply with the Covered Homeless Organization ("CHO") agreement and document in accordance with the Homeless Management Information System ("HMIS") requirements.
- C. Provider must provide services to a minimum of thirty-four (34) unduplicated Clients at all times during each term of the Agreement.
- D. Standards and Other Requirements:
 - 1. Standards:
 - a. Provider must adhere to the standards and other requirements stated on all Contract Adjustments and the Provider Handbook, as applicable, accessible online at http://www.broward.org/HumanServices/CommunityPartnerships/Pages/ContractServices/ProviderHandbook.aspx.
 - b. Provider must adhere to Broward County's Standards of Care accessible online at https://www.Broward.org/HumanServices/CommunityPartnerships/HomelessinitiativePartnership/Pages/CoCStandardsofCare.aspx.

2. Other Requirements:

- a. Provider must register staff to receive alerts regarding revisions to the CPD Provider Handbook and related documents through AccessBROWARD, https://access.broward.org/About.aspx.
- b. Provider must complete the Housing Quality Standard checklist for each client prior to placing a client into housing.
- c. Provider will document Fair Market Rent in the client file as referenced in the Provider Handbook.
- d. Provider must collaborate with Family Success' Housing Options Support Team when placing clients in housing.

E. Services to be Provided:

Rent Payment Assistance (BH-3800.7000)

Provider will provide the following services, as further detailed in the "Scope of Services" Section or in the Contract Adjustment(s). The Cost per Unit of Service, Required Staff Credentials/Licensure and Unit definition are set forth in the Community Partnerships Division Taxonomy Definitions Credentials outlined in the Provider Handbook at: (http://www.broward.org/HumanServices/CommunityPartnerships/Pages/ContractServicesProviderHandbook.aspx):

- G. Location(s), days, and hours of service: Provider's administrative offices are located at 4780 North State Road 7, in Lauderdale Lakes. The Provider will provide Clients housing located throughout Broward County. Provider will provide services to Clients from 7:30 a.m. to 5:00 p.m., Monday through Friday. Provider will not provide services during the following observed holidays: Thanksgiving Day and the day after Thanksgiving Day, Christmas Day, New Year's Day, Dr. Martin Luther King Jr. Day, Memorial Day, Independence Day, Labor Day, and Veteran's Day. The Provider will notify the Contract Manager in writing of additional office closures.
- H. Commission Districts: At the date of execution of this Agreement, the Provider's service hub(s) are in the following Commission District(s): number(s) 9
- II. Maximum Number of Units to be Purchased/Maximum Dollar Amount:
 - A. Units for Term of Agreement: N/A

Units per Extension, if exercised: Shall be equal to a pro rata number of units of the then current annual units per service.

- B. \$ Amount for Option Period 2 of Agreement: \$ 496,310.00
 - \$ Amount per Extension, if exercised: Shall be equal to a pro rata amount of the then current annual funding amount.
