The Domestic Violence Intake unit provides assistance to those affected by domestic, repeat, sexual, dating, and stalking violence who in need of obtaining an injunction for protection. Injunctions are commonly referred to as “restraining orders”.

To obtain a Restraining Order, you may eFile your pleadings utilizing the ePortal filing system or appear in person at one of the Domestic Violence Service Locations, excluding Courthouse Holidays. The decision is made the same day and the Petitioner/Counsel is responsible for obtaining a copy of the ruling along with all associated documents.
